The **SafeGait 360° Balance and Mobility Trainer®** is a dynamic body-weight support and fall protection system.

Developed in collaboration with rehabilitation experts, the SafeGait 360° includes proprietary Patient Management Software that collects real time data on patient progress by task and by session.

► BETTER PATIENT OUTCOMES

By facilitating patient confidence, mitigating fear of falling and promoting greater challenge, patients using SafeGait 360° can achieve faster rates of recovery.

► SAFER PATIENT HANDLING

SafeGait 360°'s dynamic body weight support and fall protection benefits clinicians and patients by reducing injury risk during therapy.

► 1:1 INTERACTIONS

With SafeGait 360°, facilities can reduce length of stay, increase patient volumes and achieve higher productivity ratios through 1:1 interactions.

► DYNAMIC MOVEMENT

Patients have the freedom of fully dynamic, barrier free movement with the assistance of constant body weight support.

► DYNAMIC FALL PROTECTION (DFP)

SafeGait 360° proprietary software distinguishes between intentional movement and a loss of balance (LOB). DFP is velocity based, always active and provides protection without the need for therapists to adjust fall limits.

► DYNAMIC FALL RECOVERY (DFR)

In the event of a LOB, dynamic fall recovery (DFR) allows the patient to pause and process their fall and regain stability at their own pace, retraining automaticity.

In the event that a patient requires additional support, the therapist can decide to use Controlled Assist to help the patient recover.

► CONTROLLED ASSIST

Ability for therapists to use the device to assist with fall recovery or as an emergency lower.



ADDITIONAL PRODUCT FEATURES

▶ BODY WEIGHT SUPPORT (BWS)

Static body weight support of up to 450lbs. Market leading dynamic body weight support of up to 225lbs.

▶ DESCENT LIMITS

A secondary fall protection feature that sets a maximum amount of downward travel based on the patient's position and height.

▶ BOOST

A temporary 20% increase in bodyweight support for 10 seconds as needed for transfer activities (i.e. sit to stand).

▶ HORIZONTAL LOCK

Suspends horizontal movement, while allowing vertical travel as desired (i.e. treadmill training and push/pull tasks).

SafeGait 360° features an intuitive user interface that allows therapists to track and compare **session** and **task data**.

Therapists can create their own fully customizable Plan of Care, or choose from an extensive library of transfer, gait, and stair tasks to meet the individual goals and needs of their patients.

► PATIENT DATA

Create, edit or search specific patient metrics to track progress.

► PLAN OF CARE

Customize unique therapy sessions using an extensive library of gait, transfer, and stair tasks, or create new tasks. Set performance goals to challenge patients to work harder and encourage success.

► MONITOR TASK PERFORMANCE WITH EASE

Accurately capture key performance measures: time, distance, repetitions, falls prevented, average BWS and speed. Document Rate of Perceived Exertion (RPE) after each task.

► REVIEW AND COMPARE HISTORICAL DATA

Demonstrate patient progress graphically by comparing historical data for tasks and sessions.

► PATIENT DATA EXPORTS

Export data in charts, summaries or CSV file formats.

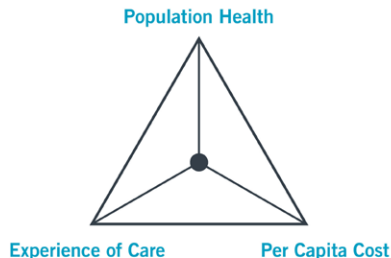
► POPULATION HEALTH
